



## Contest Rules – WONCA Europe 2026 Conference

### 1. Organizer

The contest is organized by the *Collège de Médecine Générale (CMG)*, as part of the organization of the **WONCA Europe Conference 2026**, whose registered office is located at 6 place Tristan Bernard, 75017 Paris, represented by Paul Frappé.

### 2. Contest Duration

The contest takes place during the following conferences:

- **WONCA World Lisbon**, 17–21 September 2025 in Lisbon
- **Confédération des Syndicats Médicaux Français (CSMF)**, 2–5 October 2025 in Paris
- **Journées Nationales de Médecine Générale (JNMG)**, 9–10 October 2025 in Paris
- **Congrès National des Centres de Santé (USPCS)**, 9–10 October 2025 in Paris
- **Collège National des Généralistes Enseignants (CNGE)**, 3–5 December 2025 in Toulouse
- **ISNAR-IMG Congress**, 22–23 January 2026 in Dijon
- **ReAGJIR Congress**, 4–5 June 2026 in Epinal

Any participation outside these dates will not be considered.

### 3. Participants

The contest is open to any natural person of legal age, except members of the organizing team. Participation is free and without any purchase obligation, in accordance with **Article L121-20 of the French Consumer Code**. Only one participation per person is allowed (same name, same email address).

### 4. How to Participate

Depending on the format used at each congress, participation may be digital or on paper, according to the rules below:

- The organizers reserve the right to modify, postpone, or cancel the contest in case of force majeure or technical reasons

#### **5. Personal Data**

These data are processed by **CMG** and the company **Overcome**, mandated for logistics, within the organization of the **WONCA Europe Conference 2026**, in accordance with **Regulation (EU) 2016/679 of 27 April 2016 (GDPR)** and **French Law No. 78-17 of 6 January 1978** relating to data protection.
